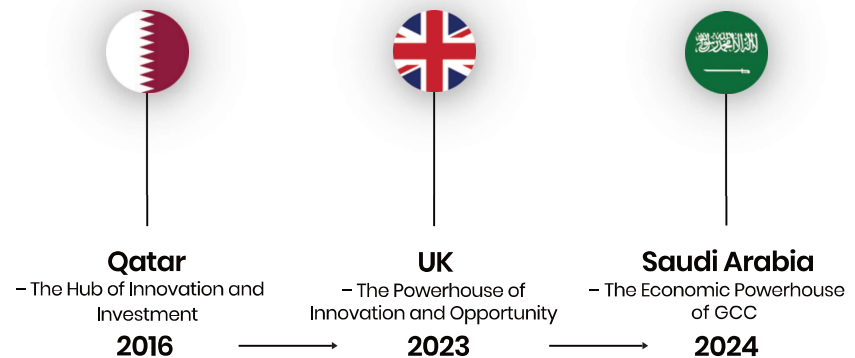

Regulates businesses in financial services and professional services sectors under a unique legal framework.

Establishing a Business in **Saudi Arabia**

Entrepreneurs looking to set up a business in Saudi Arabia have three main entity options:



Branch Office

A branch office functions as an extension of an existing company, operating under full ownership of the foreign investor. Although it is physically separate from the head office, it remains directly accountable to it, reporting all key data and operations.



Subsidiary Company

A subsidiary is a separate legal entity in which a parent company holds a controlling interest. Unlike a branch office, a subsidiary does not report to the parent company but rather to the holding corporation that owns it.



GCC National-Owned Investment

This business structure is specifically designed for nationals of other GCC countries, enabling them to establish businesses in Saudi Arabia with the same rights and benefits as Saudi nationals.
